It stems partially from the platforms' economic impact, which is felt most acutely in certain sectors: Uber drivers compete with taxi drivers; Airbnb hosts compete with hotels. U.S. Army Special Forces leaders must understand the different and complex nature of conducting UW with partisans in a mid to high intensity conflict, though, if they are to remain prepared to conduct these operations. The amount of lead time required to develop such a capability will probably not be available in future conflicts.
